Called Meeting to order & Establish Quorum Administrative:

 Motion was made to approve the purchase of Lot # 397 by the Tanners. Motion was seconded and approved.

• Motion was made to waive all late fees and money owed by previous renter of lot 390. Motion was seconded and approved.

General Park Business:

• Discussion about budget that would be presented by Real Manage prior to the end of 2023 for 2024. Pete discussed he would also be putting a budget together to compare to Real Manage.

• Discussion about verifying current committee members of various committees and if all the committees are needed.

• Blue Stream Fiber Optics. Discussed them now being in Venice Isles replacing Comcast due to better rates. Took Blue Stream 1 year to run the Fiber Optics in Venice Isles. Also Blue Stream sent Sandalwood a letter asking for an easement down Cortina to run a secondary Fiber Optics line into Venice Isles. Letter said they want to run it on the east side of Cortina and the Board discussed we would rather have it run down the West side of Cortina. Also, we may use the approval of the easement to negotiate a future rate discount on a possible switch from Comcast. However it was pointed out that Sandalwood is under contract with Comcast through July of 2025.

• Discussed the deadline for repairs on property in the park is 2 years from the date of Hurricane Ian, which is September 28th, 2024.

• Discussed that compliance letters will be started back up in September or October.

• Discussion and possible solutions for reporting landscape issues in the park.

• Lonnie reminded residents about the Rules and Regulation meetings coming up in December and January.

• Reminder was given about dogs needing to be kept on a leash when they are outside.

• Fema house was discussed and it was confirmed that it would remain in the park for 18 months from the date of the Hurricane.

Motion was made to adjourn, seconded and meeting was adjourned

Update was given on the stump grinding of palms and trees we lost during Hurricane Ian. Some stumps still remain that are being addressed. Yearly palm trimming is set for middle of December.

Blue Stream Fiber Optics

Discussed that this is a new TV and internet supplier that is now in Venice Isles. We contacted them for pricing and they are looking into a quote. They also sent us a letter to ask Sandalwood for a variance to put a secondary Fiber Optics line down Cortina. We are going to contact Blue Stream to see if they were going to pay for the variance and to change the location to the west side of Cortina.

Compliance

It was discussed that some homes have not yet turned in ARCS for their repairs from Hurricane Ian. It was noted that residents have 2 years from the date of the hurricane to complete repairs which would make the repair date September 28th 2024. It was discussed to send out letters to all residents that have either not turned in an ARC or have not completed their repairs.

Landscaping

Rick discussed the possibility of getting fencing on Cortina from the start of our property to the entrance due to the bushes dying. It was decided to get pricing and table the discussion.

Operational Budget

Pete discussed that he had a preliminary budget put together and he would be finalizing it for the November meeting. Motion was made to adjourn

President's Report

• Board Elections > Dave gave notice that if anyone is interested in running for the Board there will be two openings. Lonnie Grooms has fulfilled his 1 year term and Larry Reed has served 8 consecutive years and per Florida HOA rules cannot serve another consecutive year unless no one runs. Anyone interested should get a form from the office and submit a resume. Cut off date for applying is Friday December 8th.

 CPA Review of 2022 Financials > Pete announce that the CPA did a review of 2022 and found everything to be okay. A resident asked why an audit was not done since the Board voted to do an audit and not a review? Lee stated that a mistake was made in the engagement letter prepared by Real Manage and then signed by the Board President and sent to the CPA. He stated that the Board had voted and passed for an audit of 2021. The mistake was discovered too late and when the CPA was contacted he had already gone too far into the review of 2022 to start over with an audit of 2021. Another resident stated that an audit is supposed to be done every 3 years and another resident said that an audit can be waived at the Annual Meeting of the Shareholders. Lee stated that an audit had not been done in the Park for 9 Years. It was also stated that the audit would have been \$ 10,500.00 and the review was \$6,500.00 and a normal tax return would have been \$450.00 which Lee stated was all that was needed in lieu of the audit.

• Employee 5% Wage compensation> It was discussed that we have two employees that are paid by Sandalwood Park, Peggy in our office and Bob who is our Grounds Keeper. It was proposed by the Board to give them both a 5% raise starting in 2024. Residents and the Board acknowledged the good job they both do. A Motion was made by Rick to approve the 5% raise and it was seconded by Larry and it passed Unanimously.

• Blue Stream Fiber Optic Variance on Cortina for Venice Isles > Dave stated that the Park had received a letter from Blue Stream asking for a variance to bring a secondary line into Venice Isles down Cortina on the east side of the road. After Board discussion, Dave asked Blue Stream why it could not be put on the west side of Cortina and if Blue Stream was going to pay any compensation for the variance and the fees to our attorney for preparing the variance? Blue Stream declined any compensation so the Board is not addressing or allowing the variance. Treasurers Report

• Budget Estimate for 2024 > Pete explained he used the July and August actual expenses along with the previous years data to prepare the budget for 2024. It was explained that due to the increase in utilities and lawn care the quarterly HOA dues will need to be increased to

\$488.78 in 2024. Pete made mention of a line item noted as "Contingency" for \$10,000.00 that will more than cover the 5% raise previously approved in this meeting. The conversation shifted to insurance and it was stated that our insurance company had dropped us for 2024. It was further stated by the Board that we received approximately \$ 37,000.00 for fencing but nothing for the repairs of the cubhouse roof or any other repairs. It was stated by a resident and the Board that we should consider "Self Insuring" the park and only carry liability since we have nearly \$800,00.00 in reserves. The Board said they will be getting insurance estimates and Pete noted any insurance savings would go toward reserves.

#### **General Business**

• Simply Trees Update > Larry stated that most of the stumps had been removed but there were still some that need to be taken out. He said the annual palm trimming will take place on December 19th. A resident made a comment that he felt the palms should be done right before Hurricane season. Larry said that for years it has always been done in the late fall. It was also mentioned that the owner of Simply Trees who is an arborist looked at the palms in May and said they didn't need trimmed.\*

• Bob's Electric > Larry stated that we had received a quote from Bob's Electric for

\$2,350.00 to provide and install 3 new ceiling fans on the rear patio, replace 2 photo cells behind the clubhouse, adjust the timers on the front security lights of the clubhouse, replace a photo eye on the sign at Cortina & Center Road and provide and install 2 LED lights in the supply room. Larry wanted to increase the quote to \$ 2,550.00 to cover a couple other items needing repair. Lee made a motion to approve and increase the quote to \$ 2,550.00, it was seconded by Lonnie and approved unanimously.

• Hurricane Compliance Letter > Vote was needed to have Sandalwood handle the issuing and monitoring of letters to 46 Homes in the Park that have not yet completed their hurricane repairs in lieu of having Real Manage handle It. The repairs must be completed by September 28th 2024. (Normal grievance letters to remain through Real Manage ) Dave stated that the Board was divided on this decision

and that historically all letters of notice are sent out by the management company. Lee stated that Real Manage has not done a good job of handling all their duties for the park and other letters such as compliance for golf carts was never sent out. He felt the Sandalwood office should handle the issuing of the letters and monitor the responses due to the importance of the situation. Also that there could be some residents that are financially unable to do the repairs and that the park needs to be ready to address those situations. Lee made a motion to have the park handle the compliance letter for the home repairs still need to be done on the 46 homes but continue to let Real Manage handle normal compliance letters. It was seconded by Larry. Dave and Butch voted NO and Lee, Lonnie, Rick, Pete and Larry voted YES so the motion passed. It was also noted that the Board was getting guotes from two other management companies and that the Board was looking at
