## Happy Valentine's Day



From the President:

This is for sure my final article as SPH President. My term as Director is expiring and I'm not on the ballot. Please allow me to reminisce over the seven years I've served as President of SPH.

I start by honoring those who served in my position and on the Board before me. They did just what was required to bring Sandalwood to private ownership and install an organization to successfully operate this cooperative. Be assured that any of my comments are not to be critical of anybody who has given of their time and energy for the sake of our park.

In 2005, I asked you to elect me to the Board with intentions of being part of changes that would allow us to build on the foundation that had been

established. The following year (2006) you elected others with the same intentions and the remaining board members bought into the program. The changes and accomplishments were definitely a "we" program involving eighteen board members as well as the support of shareowners.

Our first change was to improve our financial position. Previously the Board had received permission from our bank to use 50% of share sales for operating expense while spending over \$17,000/year on loan interest. We committed 100% of share sales to loan principle and added some funds from savings to retire our debt in March, 2007. Since then share sales have only been used to construct our clubhouse addition. After spending \$500,000 for the addition, we have still increased our savings by nearly \$200,000 with no increase in maintenance fees.

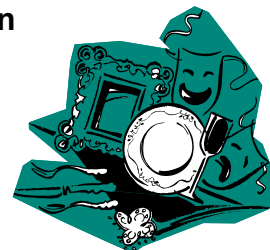

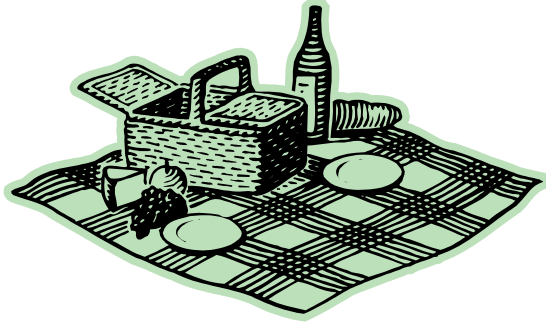

Our rules had been enforced by letters from attorneys threatening eviction. I remember receiving one for a violation which I did not know was a rule. Persons actually toured the park looking for violations. We now operate with a "Problem Solving Committee" where reported rules violations are handled in an appropriate and confidential manner to solve the problem without embarrassment. Sometimes volunteers are even recruited to correct a problem. Attorney letters are a last resort.

Park rules can be and are changed by Board action. A master set of rules is now kept on the office computer so any new sets passed out include all revisions.

I remember when board meetings were a shouting match between Board members and Shareowners. People came to meetings to witness the fireworks. Our policy now provides for Shareowners to speak on agenda items and followed by board discussion and action. People now come for coffee and cookies and to see the board members perform their duty.

I also remember after annual meetings the new board would retire to a back room and conduct a battle to choose new officers. We now ask the Shareowners to stay and observe the orderly process in front of them.

An asset which we have all valued is preservation of our open spaces. This was previously done by arbitrary policy developed by committee. We changed the rules to increase side yard setback from 5 ft to 7 ½ ft and to limit maximum width of a home and carport to 44 ft. We also abandoned improper use of suggested inaccurate lot dimensions in an obsolete prospectus in favor of guidelines in OUR prospectus.

We also developed a procedure with proper documentation for Shareowners to allow use of their homes by family or friends. It includes responsibility for informing of rules and signature of a Board member.

I do recall an Annual meeting that had to be repeated because we did not have a quorum in attendance or by Proxy. We have solved that problem by providing a Proxy form and return envelope with the meeting notice.

Sandalwood Activities Club was once treated as a nuisance stepchild receiving little support from Sandalwood Park Homeowners, Inc. We now consider SAC as a sister organization and support them financially and with office assistance. This has resulted in a major increase in quantity and quality activities.

Our biggest change has been increased cooperation among residents with differing opinions to cooperate with neighbors for improved comradery in our community. It has truly become a friendly, happy place.

We've even figured out how to allow golf carts and small scooters in our park and allow small boat storage in carports during the summer.

Our environment has allowed us to add amenities to our park. The major improvement has been a much needed \$500,000 clubhouse addition and renovation. It came about by great cooperation among Shareowners with differing ideas but a common goal. We obviously got what we wanted as I have heard nothing but positive comments about the finished product.

We recently added a Pavilion which we expect to find many uses. It definitely adds to the appearance of our park.

Our pool was renovated in 2007 at a cost of \$71,000. This included a new liner and brick pavers.

We have resurfaced all park roads at a cost of \$180,000 and have also resurfaced Cortina Rd. and added a sidewalk/bike path. This greatly improves the appearance and safety of our property.

We've developed "Veteran's Park" which flies both American and Canadian flags while honoring Veterans of any country.

We have improved relations with Venice Isle Estates and share in some events.

We even revolutionized Bingo, SAC's most popular activity. We replaced the old, antiquated, Bingo machine with big screen computer technology.

I reviewed my first letter to SPH Shareowners in March, 2006. My expectations have been exceeded! I hope yours have as well. I thank you all for a very enjoyable and rewarding experience.

On February 14 we will have some new board members and a new President. I challenge them to use our past to avoid returning to policies which we have outgrown. Instead, improve on what we have passed on to your charge. Sandalwood has been declared a "great place to live", you can make it better!

Bring your appetite to the monthly Pancake Breakfast on Saturday, February 16 from 8 a.m. to 9:30 a.m. in the Sandpiper room.

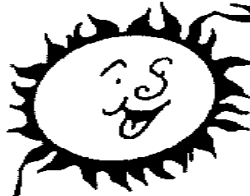
Tony Ellis and his committee will flip those discs, and serve them with sausage, orange juice and coffee.

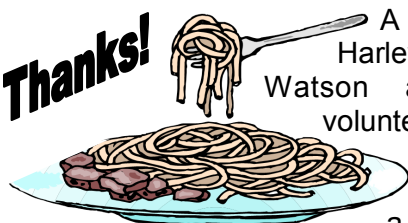

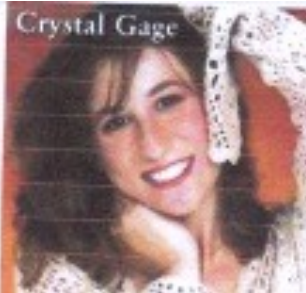


## Sandalwood Park Entertains Famous Personalities in 2013

Fortunately for all members and friends of Sandalwood Park, we have Grammy nominees coming to entertain for minimum costs to us.

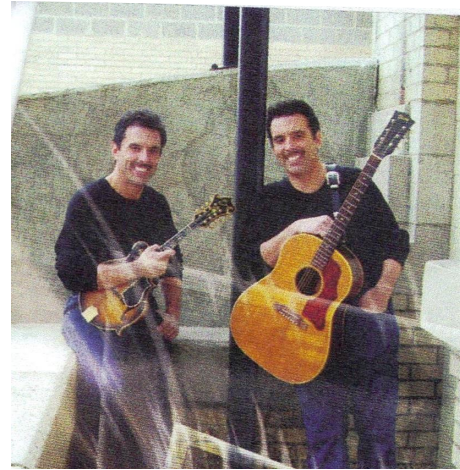

## COOKS CORNER



### Double Chocolate Chip Cookies from Crisco



- ¾ stick Crisco baking sticks or ¾ cup Crisco all-vegetable shortening
- 1 ¼ cups firmly packed light brown sugar
- 2 tablespoons milk
- 1 tablespoon vanilla extract
- 1 large egg
- 1 ¾ cups all purpose flour
- 1 teas. Salt
- ¾ teas. Baking soda
- 1 cup semi-sweet chocolate chips
- 1 cup coarsely chopped pecans (optional)

Heat oven to 375 degrees. Beat shortening and brown sugar in large bowl with an electric mixer at medium speed until light and fluffy.

Beat in milk, vanilla and egg.

Stir in flour, salt and baking soda.

Blend in chocolate chips and nuts.

Drop by rounded measuring Tbs. 2 inches apart onto ungreased cookie sheets.

Bake 8-10 minutes for chewy cookies or 11 to 13 minutes for crisp cookies. Cool 2 minutes on cookie sheet. Transfer cookies to cooling rack.

TIP: If nuts are omitted, add an additional ½ cup semi-sweet chocolate chips.

Makes 3 dozen cookies.
