

From the President:

Since I have been elected to serve as your President for a sixth year, I feel an obligation to point out a few things needed for Sandalwood remain the best place in the world to live.

There is a "NO SOLICITORS" policy in our park, but recently the meat peddlers returned, going door to door soliciting residents to buy their goods. Their favorite words are "God bless you". But when I confronted one of them, he told me what he really meant and it didn't involve God. I doubt that it was a coincidence that several bicycles were stolen during the same time period. If these venders return, remind them of the "No Solicitors Policy" ask them to leave Sandalwood immediately or you will call 911. You can always call a Director or 911 for assistance if needed. Only deal with those who you have asked to provide services. If anyone else comes to your door, ORDER HIM OR HER OUT OF THE PARK.

Frequent rule violations will not be tolerated. We want to be a friendly park and not a police state, but we also need to keep ourselves in check. The "No parking on the grass" rule was modified to allow short-term daytime parking with two wheels only on grass. But now there are vehicles parked fully on the grass all day. If you need additional parking, a parking slab next to your carport can be evaluated, if room permits. Otherwise, parking by the clubhouse is provided and must be utilized for parking of extra vehicles. We do allow grass parking for events at the clubhouse.

Sandalwood is unique in allowing pets, and I think that is great. But, some abuse this privilege. Pets must be kept on an attended lease when outside. Fences, visible or invisible, are not acceptable or even allowed according to Sandalwood rules. Droppings must be picked up in ALL areas, including your own property. You must also prevent barking that might annoy neighbors.

Some units and yards are in need of attention. Our Beautification Committee should not have to remind you. But, if and when they do, please respond in a positive manner and promptly attend to their request.

Last, but not least is the biggest and most serious violation....SPEEDING! The road you are driving on is also our sidewalk. Don't be the driver that runs down someone coming out of a driveway in a wheelchair, on a bike or simply taking a walk. SLOW DOWN.

I'm fine with bending the rules a bit, like with the parking, but please don't break them. If your "self examination" reveals a violation, please do a "self correction". It takes everyone's cooperation to keep our park the great place where we are proud to live.

# SANDALWOOD PARK HOMEOWNERS, INC. PRESIDENTS REPORT OF BOARD ACTIVITIES ANNUAL MEETING 2/17/11

While the most significant accomplishment of last year was the completion of the clubhouse addition, the most significant accomplishment this year was paying off the loan to build it. It's a pleasure to inform the membership that we are again debt free. We are very pleased to see the facility is quite busy and that it has fulfilled the needs of our community. With increasing demand for use for private parties, the board adopted a \$100 user fee for use of the Sandpiper room when it is not being used for park activities.

Furnishing of the Exercise Room was completed with the purchase of a television. This room, made available with our clubhouse expansion, has proven to be a well used addition to our facilities.

Golf carts are now officially approved for use in Sandalwood but must be registered with the park office.

A generator was purchased for the price of \$300.00 to provide basic power in case of an extended outage.

SPH accepted the donation of mobile homes on rental lots 400 Longwood, 554 Aspen, and 421 Boxwood. Each home was removed and lots offered for sale at the \$50,000 share price. Lots 551 Aspen (previously donated) and 400 Longwood were sold at the \$50,000 share price while 554 Aspen, 421 Boxwood and 464 Boxwood are for sale as vacant lots. Our park is improved by new homes at 405 Longwood and 551 Aspen with another being planned for 400 Longwood.

The front retention ditch was cleaned at a cost of \$5,000 to provide additional runoff capacity. Also, \$4,200 was spent on road repairs. We have now committed to totally resurface all asphalt within the park at a cost of \$180,155.00. The work is to be completed during the summers of 2011 and 2012 as funds become available through lot sales. No funds are to be borrowed for this improvement, nor are maintenance fees to be increased.

Norm Vandenbusche was appointed to fill the board position created by the death of Henry Bukowski. Henry was recognized for his long term dedication and service as a member of the Board.

Veterans Park was established on the recommendation of the Beautification Committee. This area near our main entrance is available for memorials to veterans who have lived in Sandalwood.

The annual trimming of palm trees was completed as was the annual spraying to control fire ants. We renewed the \$4,500.00 contract for the very effective annual fire ant prevention.

We continue to operate very efficiently with just two part time outstanding employees. We are very fortunate to have dedicated park residents in these two positions. Marietta Jones works approx. 20 hrs/week as office manager. We truly appreciate her skills in all office functions as well as handling share sales and transfers. Our maintenance manager, Charlie Kane, continues to excel in maintenance, grounds keeping and janitorial duties. He works 35 – 40 hrs per week

The board of Directors serving for the past year were Carl Van Gilst, President; Harley Wheeler, vice president; George Taylor, Secretary; Dan Hutchinson, Treasure; Joe Cromwell, Assistant Treasurer; John Dane, Henry Bukowski (replaced by Norm Vandenbusche), Sandra Marsocci, and Mitch Watson. Appointed by the board as assistant secretary was Marietta Jones.

Our share price remains at \$50,000.00. Three of these shares are currently for sale by the corporation while we have nine remaining renters. Our goal is to become 100% resident owned. As our treasurer has reported to you, we are very sound financially with very adequate, and growing, reserves to meet any emergency. We do not anticipate any increase in maintenance fees in the foreseeable future. The value of our corporation remains at \$12,000,000.00
