President's Corner

Your new board is busy getting started and getting familiar with the inner workings of Sandalwood Park. It is our goal to improve communication to the owners and keep them informed of what's happening in our Park. We are a 7-member board of directors that are unpaid volunteers. If you have a question, concern, problem, complaint, or idea on a day-to-day basis you can forward those to the office by email at Sandalwoodoffice@gmail.com or drop it in writing in the mail slot at the office door. It will be forwarded to the appropriate committee or board member. The need to call board members should only occur in an emergency (fire, flood, death, hurricane, tornado). If it involves theft, fire or health emergency, please call 911 immediately.

Our efforts to improve the information flow has started with some changes to our information channel 195. Marcie Able regularly updates channel 195 and is doing a FANTASTIC job of keeping it current. Please check it out as it is full of info. I am planning to continue this informational note in the newsletters and am open to suggestions, ideas, constructive criticism, and complements.

I plan to do a brief review of one or two of the rules and regulations each month as a friendly reminder to us all. This month I am reviewing:

Architectural review forms – please see Rules and Regulations 2.5 Any outside unit modification is to be completed, in its entirety within 45 days of start. 2.6 all modifications to the outside of the unit must be approved by the board. This is done by submitting an ARC form available outside the office door in the plastic holders. There has been some confusion about this when a compliance letter is received that indicates need for something such as painting. The letters have been changed to indicate that you should call the Sandalwood office in response to the letter rather than Lighthouse. Lighthouse can not give approval for changes, so when they responded to the caller it was misunderstood by all that it was permission to make the changes without the form. When you submit your completed form to the office it will then be forwarded to the ARC Committee for evaluation and reports and recommendations will then be forwarded to the Board.

It has been brought to our attention that courtesy toward our neighbors has declined in some instances. These are our homes and our private yards, not all areas are common grounds. Our neighbors deserve our respect toward them, their property, and their homes. Please Do Not walk through your neighbors' yards, driveways, carports, lawns, etc as a means of a short cut to any activity, other home, or community building or street. Please remain on the street with your bikes, golf carts, pets, and when walking, jogging or biking. There is a driveway off Ashwood that can be used to access the air pump at the garage shed.

Several projects are in the works and others are under review. The back gate camera should be functional by

mid- March. The landscaping around the pool area has received additional bids and one landscaper feels that cutting the plants back may encourage new growth. This is being considered as a lower cost option to replacement. The back wall along Pinebrook is scheduled to be cleaned, repaired, and painted by the county in March. This request was made to the county last summer. The burnt out Sandalwood sign at Center and Cortina has been replaced. You may have noticed that the back gate is now functioning properly. The eye that controls the opening and closing needed replacement which has been done. The streetlight in the northeast corner of the park on Longwood has a short in the underground cable. It has been disconnected and is slated for repair by FPL (no date has been given). Finally, you may have noticed that our maintenance man, Jim, is no longer here. He was injured in October and is not able to return to work. We have hired a new man, Brett, who will begin regular part time hours here toward the end of February. Until then, he is filling in with a few hours a week. If you see him, please welcome him! He is a very friendly and an experienced, hard worker.

FLORIDA SEA TURTLES

5 species of Sea Turtles inhabit Florida's waters though only 3 species nest on Florida's beaches. Florida is one of the largest nesting area in the world for Sea Turtles. Nesting season is from March 1 thru October 31st. When visiting Florida beaches during this time it is not unlikely that you will see areas marked or roped off where a sea turtle nest is (as they are protected by the Florida State Statutes, Chapter 370.12). And most beaches where they nest have a "lights out" policy after a specified time to prevent the sea turtles from going toward the lights.

Sea turtles can lay several nests in one season, in each nest laying approximately 100 eggs. The female covers the eggs with sand and then leaves the eggs to incubate for 2 months. The temperature of the nest actually determines the sex of the turtles. When the eggs hatch, the hatchlings race toward the water. A very small percentage of the hatchlings ever survive and live to adulthood. The females who do always return to nest on the same beach where they hatched.

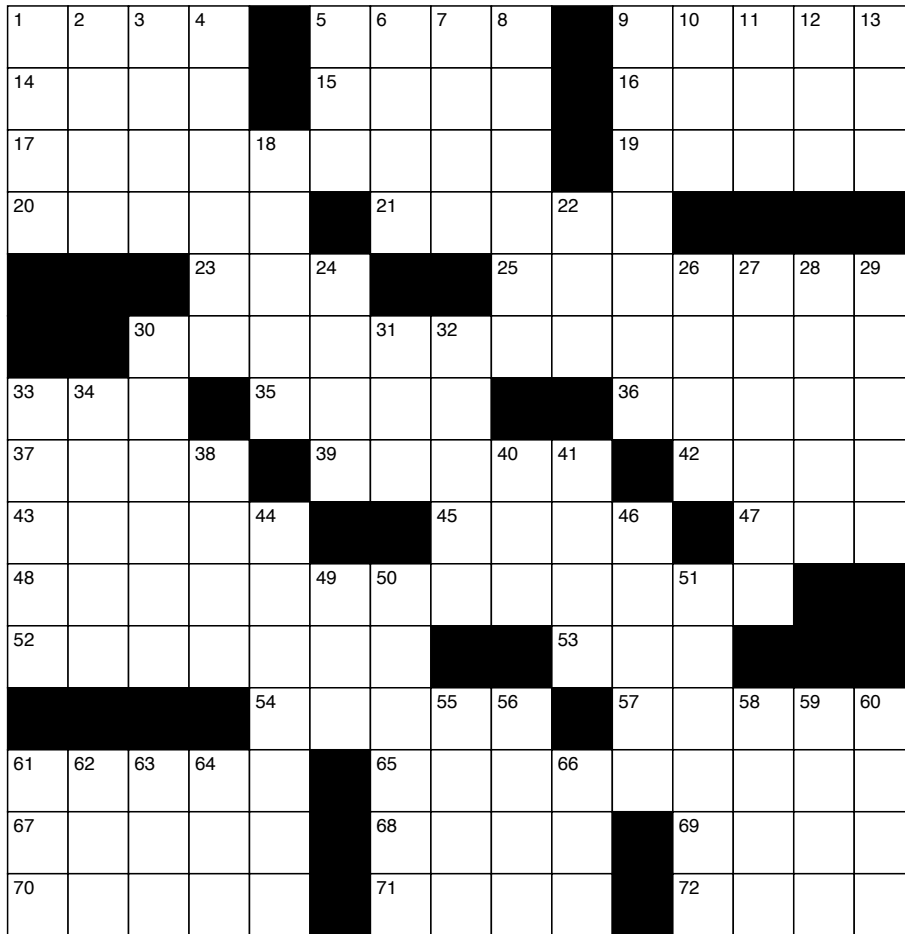

COMMITTEE HELP NEEDED

SPH will be reactivating committees and would like your help with these as it is your park, and your input and assistance is required. The committees are Finance, Architectural Review, Compliance, Grievance/Fining, Landscaping, Maintenance, Emergency/Safety Planning, and an Ad Hoc committee to review the Communication Consultants findings and evaluate options for Cable services next year. Committee duties are as follows:

FINANCE

- Review annual budget as submitted by Lighthouse.
- Review Monthly financial statements.
- Prepare/recommend share price, rent and maintenance changes to Board.
- Manage and recommend contingency fund investments.
- Review Committee's requests for expenditures.
- Negotiate loans if needed.

ARCHITECTURAL REVIEW

- Review plans and supervise installation of new homes.
- Review proposed changes to homes, Architectural Review forms and make recommendations to the board.

COMPLIANCE

- Makes tours of the park to determine if homes are following the By Laws, Rules and Regs.
- Manager from Lighthouse will make monthly tour with a committee representative and will send violation notices.
- Two committee members will make a follow-up tour two weeks after the initial tour to verify correction of the violations.
- Chairperson will send notice email to Lighthouse of incomplete corrections.
- Second notice will be mailed to owners with incomplete corrections.
- Second verification tour will take place two weeks after second notice is sent.
- Violations that are not corrected or responded to with intent to correct by owner will be brought up at a board meeting for vote on intent to fine.

GRIEVANCE/FINING

- Hearing for residents who have been fined for violation(s).
- Meeting held 15 days after Board Meeting.
- Recommendation is made to the Board whether fine stands or removed.

LANDSCAPING

- Evaluate landscape on common grounds, determine if additional changes are needed, if replacements are needed and recommended timing.
- Obtain plan and 3 bids and present to Board for vote.

MAINTENANCE

- Review proposals from contractors.
- Review park maintenance needs.
- Prepare recommendations for maintenance plans (i.e. Reserve Study, building and pool).
- Consider capital improvement projects with coordination of Finance Committee.
- Assist Board in management of park assets.

EMERGENCY PLANNING/SAFETY

- Identify areas of concern in Sandalwood Park that could become a problem in emergency situations.
- Develop procedures and regulations on how to prevent and handle emergency situations at Sandalwood Park.

AD HOC COMMITTEES (Temporary committee to evaluate specific needs)

- Communications Consulting Findings – 2022
- Evaluate the bids sent by the consulting firm, remaining in compliance with By Laws.
- Set up information meetings for residents, if needed.
- Report findings and recommendations to the Board for vote.
