From the President:

In last month's letter, I thanked residents who volunteered to serve on the various committees. The response has been good and volunteers continue to sign up. Thank you all for your service to Sandalwood Park.

A special thank you to Al Brown, Carl Didonato, Don Souza, Ken Jager, Larry Moore and Larry Reed for assisting their neighbors by cutting down dead/dying citrus trees.

This month four of our Board met with four of the members of Venice Isle's Board to discuss the following topics of mutual concern:

 Speeding and running stop signs. VI has purchased a "YOUR SPEED IS" radar sign, and will be using it on Cortina road this spring and also next season. They will be monitoring speed and stop sign compliance, and will monitor whether the offenders are from Venice Isle or Sandalwood Park.

- We will be sending a joint letter to Sarasota County in regards to the lift station on Cortina road, and the terrible smell it produces. Perhaps as a group we can get them to address the problem.
- 3. Venice Isles was informed of the status of repairs to Cortina road and what Advanced Asphalt is planning to do to correct it. They plan to mil one and one-half inches off (this would be below the old road surface) for a strip ten feet wide, including the bike path, from the VI gate almost to the Puritan Arms entrance, and resurface that strip level with the current road surface.



4. We discussed the problem of Venice Isles residents using Cortina road as their dog bathroom, and pointed out that we put new no dog signs by the new Viburnum plantings. They will again address this in their newsletter and at meetings. They also are discussing making the whole park pet-friendly, which would reduce the need to bring Fido out to Cortina road.

If you plan to let relatives or friends use your Mobile Home while you are not present, you must fill out a request (forms available at the office), and submit it to the Board at least two weeks prior to their arrival.

You must then receive written permission from the Board prior to the guest's arrival. The guests must check in at the office when arriving and when departing. All requests must include at least one responsible adult with guests.

The Sandalwood Park Proprietary lease, article 15, "Use of Premises" states in part..."no guests may occupy the unit unless one or more of the permitted residents are then in occupancy or unless consented to in writing by the Directors."

CHARLIE'S HEDGE

This is one of those ideas that many of us are saying "Why didn't I think of that?" But, we all have to admit that it was all Charlie's idea.

As we were adding the new sidewalk/bike lane to Cortina, Charlie Kane, our Maintenance Manager, suggested adding a hedge between the sidewalk and the retention ditch. He then proceeded to research plant options, costs, installation, maintenance, etc. He even brought sample plants to a Board meeting for inspection.

At the February Board meeting, Charlie's proposal received unanimous approval of the Board and major support of the shareowners in attendance. Charlie then negotiated planting by our lawn mowing contractor in exchange for an unnecessary mowing and recruited volunteers to help install a drip irrigation system.

The result is the most talked about amenity addition to Sandalwood Park since our clubhouse addition. Not only is it pleasing to Sandalwood residents, it is appreciated by Venice Isle residents using the improved Cortina Road.

In answer to the many questions: The plants are Viburnum and are expected to grow to ten ft. tall and to close in the spaces between them. They maintain shinny green leaves year around. A drip irrigation system is expected to keep them growing until they establish their root system.

2014 Concert Series Scheduled For Sandalwood Park

At the last concert I addressed the audience about concerns for the concert season for the coming year of 2014. We discussed possible changes, including raising the price of tickets and having three concerts instead of four. Because of the higher cost of all the entertainers, raising the price is a necessity, regardless of our choice to have three or four shows. The tickets this coming year will be \$60.00 for season, rather than \$50.00. Basically each show will cost \$15.00 rather than \$12.50 if you have a season ticket, which is still a real value. Individual ticket costs will also need to be raised to \$20 each.


When we voted on having three or four shows, the vote was very close with a slight margin going for three shows; but when asked if people would still buy season tickets for four higher priced shows, most indicated that they would. When I went around the audience and asked people individually if they intended to get the series tickets next year, a number of couples said they changed their minds and wanted four. When the committee met and discussed the possibilities, we decided we'd like to try four concerts for one more year. One of the main concerns for people choosing three rather than four was the crowded social schedule so we have spread it the four concerts with at least three weeks apart.

All our shows this year are on Sunday nights at 7:00 p.m. The first is Jimmy Mazz, a singer and entertainer, on January 5; the second is the comedian, Rick Starr for February 16. The third entertainer is "Donna & Dunning", who sing, entertain and do impersonations on March 9. The fourth concert is a singing trio of two men and a woman, "Cover to Cover', scheduled for March 30. We know you'll find all of them worth the price of a season ticket.

Selection of seats will be at 12:00 noon on Saturday, January 4, and the order for selecting seats will be posted by January, 2014. The last show is a little later in March, but Easter is late in April; so it will probably not affect your departure plans if you are a snow bird. I can't stress enough the importance of getting season tickets to make sure that we are able to cover our SAC expenses. In the four years we've had the concert series, we have made money every year except this year. It cost us a little over \$200 extra. We didn't sell as many season tickets and the price of the entertainers has jumped quite a bit. We hope you continue to support the series, because we feel it is an outstanding plus for our park. If you plan to attend three performances, you've paid the same price as a season pass. So show your support by ordering for the season. If you do not return until after the first of the year, just call me and let me know your number of tickets for the drawing. You can pay the day before the drawing.

The committee has tried very hard to satisfy your different concerns and to give you the highest quality of entertainment. Money for the tickets will be due in the fall, and you will be given further information in a fall newsletter. Hope to see you at the concerts to enjoy some local, low-cost fun and entertainment in your own back yard!


IN MIEMORY



Tuscan Sausage Soup Submitted by Carl VanGilst

- 3 lb ground pork crumbled
- 1 T fennel seed
- 1 T salt
- 3 T chopped parsley
- ½ c oil

Fry in skillet till browned

- 1 very large onion diced
- 2 T chopped garlic
- 3 large carrots diced
- 3 stalks celery diced

Add and fry

- 3 qt chicken broth
- 2 c water
- 44 oz diced tomatoes w/juice
- 28 oz tomato sauce
- 1 T oregano
- 1 T basil
- 1 T thyme
- ½ T marjoram
- 2 t black pepper
- 2 14 oz cans northern beans (or 1 lb soaked)

Bring to boil in large pot

Add skillet to pot and simmer 30 min or more Add 1 ½ c small shells or other small pasta and hold warm for serving. Makes 9 qt.

Jewish Apple Cake Submitted by Irene Fortin

Beat following ingredients together for 3 minutes:

- 3 cups flour
- ½ teas, salt
- 2 1/4 cups sugar
- · juice of 1 orange
- 1 cup Mazola oil
- 3 teas, vanilla
- 4 eggs unbeaten
- 3 ½ teas. Baking powder

In another bowl, mix 4 large apples, thinly sliced, with 3 teas. cinnamon and 6 Tbs. sugar. Do last, so it won't get juicy.

Into a greased tube pan, pour layer of batter, then layer of apples, making 3 layers of each. End with apples.

Bake at 350 degrees for 1 1/4 to 1 1/2 hours.
