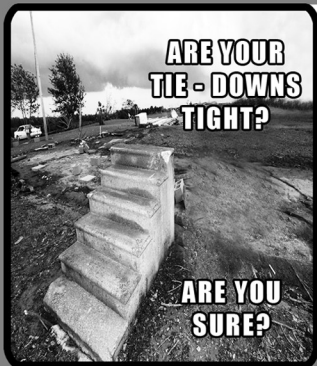

MINUTES OF THE BOARD OF DIRECTORS MEETING

March 9, 2016

A Board of Directors meeting was scheduled for 10:00 A.M. on March 9, 2016, in the Clubhouse.

The meeting was called to order at 10:00 A.M. by the President, Ms. Fortin.

Notice of the meeting was posted on the property prior to the meeting in accordance with the requirements of the Association Documents and Florida Statutes.

The following Directors were in attendance:

A Quorum was determined to be present. (*) indicates attendance via speaker phone.

UNDER THE HEADING OF READING AND APPROVAL OF MINUTES, A motion was made by Mr. Vandebusch and seconded by Ms. Moore, and it was,

VOTED 16-29: to approve the February 10, 2016, Board meeting minutes as presented.

The motion was unanimously approved by all attending Directors. Motion passed.

UNDER THE HEADING OF DIRECTOR REPORTS, regarding President's report, Ms. Fortin reported the following:

- Vegetation along Cortina Blvd. was cleaned up.
- The directory proof is being edited. Next year the directory will be ready sooner.
- She reminded owners to make sure they have a car taker form filed in the office.
- She reminded owners to change their mailing address in the office when they leave for the summer and when they return.
- A Comcast presentation will be held on March 10th at 10am.
- The anniversary party was wonderful. 207 people attended. The party came in under budget by approximately \$4,000. A picture album of the night is available in the clubhouse.

Regarding Vice President's report, Mr. Watson reported the following:

- Prices are being obtained for different options for signage and different types of speed bumps.
- Options are being looked into to upgrade the sound system. An owner advised that they would like to see a microphone installed on stage for events.

Options are being looked into for the parking area across from the Clubhouse.

Regarding Treasurer's report, Ms. Hendrickson from Lighthouse Management was in attendance and reviewed the year end and February financials (see attachment #1). Mr. Lauzon advised that CD's have been purchased with staggered mature dates.

Regarding Secretary's report, Mr. Koss advised that the revised Rules & Regulations were sent to the attorney for review. The attorney had suggested changes. The revised draft has been sent back to the attorney for final review. The final draft will then be sent to the State for approval. A copy will also be sent to all Shareholders.

Regarding Manager's report, Ms. Korte reviewed the attached report (see attachment #2).

UNDER THE HEADING OF COMMITTEE REPORTS, regarding Emergency Services, Mr. Koss advised that the committee is looking at City and County emergency plans. The committee will also be looking into purchasing a new generator. A discussion was held regarding tornado and hurricane warnings, the owners were reminded that the Clubhouse is not an approved storm shelter.

UNDER THE HEADING OF UNFINISHED BUSINESS, on matters relating to Channel 195, Mr. Belanich advised that there are 2 types of system options. New software would require a certain level of computer knowledge. Information was distributed to the Board. This was tabled to the April meeting.

On matters relating to House Numbers, Mr. Watson advised that the address numbers should be at least 4" in height and a contrasting color to the house. Address numbers should be clearly noted on the front of the units.

On matters relating to Propane, Mr. Vandebusch advised that there is an odor coming from the current tanks and that the tanks have run out of gas several times. He met with Farrell Gas and Suburban Gas to review options. Suburban Gas has offered a much lower price per gallon of propane. Mr. Vandebusch will meet with Suburban again to ascertain what size tank is needed for the community. Mr. Vandebusch recommended that the Board change to Suburban Gas. A motion was made by Mr. Vandebusch and seconded by Mr. Watson, and it was

VOTED 16-30: to change to Suburban Gas for the community's propane needs pending decision on a tank size.

The motion was unanimously approved by all attending Directors. Motion passed.

On matters relating to 401 Longwood, Mr. Rideout advised that the Owner was previously asked for a letter stipulating that the fence and gate would be removed prior to the house being put up for sale and that the Owner agrees to never have a dog while owning the unit. The Owner submitted a letter agreeing to remove the gate but not the fence. Mr. Rideout will meet with the Owner and report back at the April meeting.

UNDER THE HEADING OF NEW BUSINESS, on matters relating to property Change Requests, a standardized form was submitted to the Board for review. The new form would be required for all future property change requests. A motion was made by Mr. Koss and seconded by Mr. Watson, and it was

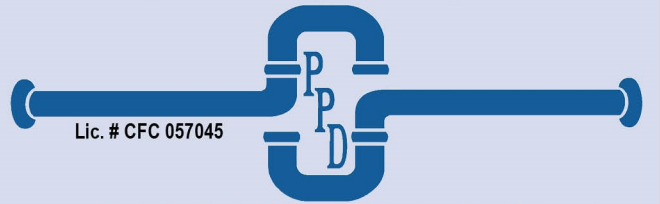
