**UNDER THE HEADING OF NEW BUSINESS**

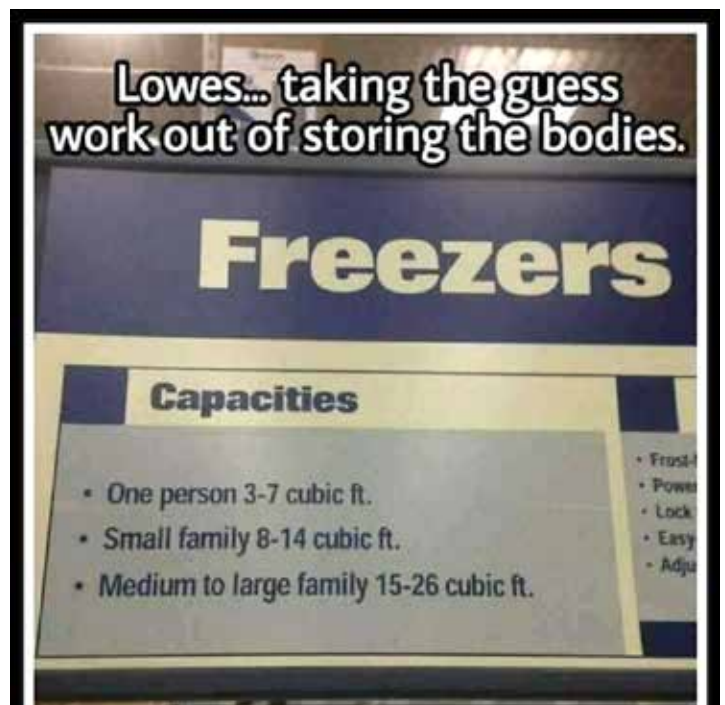

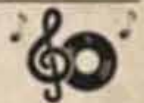

## President's Corner

APRIL 13, 2022

This month's report will be a little shorter. We have been very busy with a variety of projects and most information will be covered in the committee reports and old and new business.

I would like to thank the Sam Dick's family for their donation of the Canadian flag. It is much appreciated.

Unfortunately, we are still unable to find a maintenance employee as the ones that have applied have either been a no show for the interviews or have not responded to the request to schedule an interview. Our current plan is to hire a temporary employee to fill in cleaning the clubhouse until we can find a permanent employee. We are looking for a company to come and do a deep cleaning of the building. Also, Bobby C's will be power washing the exterior of the building, the pool furniture and the surrounding out buildings on April 18th.

We have had some people coming into the clubhouse to borrow our books and puzzles and identified themselves as Venice Isle residents and said they were given permission to borrow these items by Sandalwood residents. These amenities are for Sandalwood residents and if you know someone from outside the park who is helping themselves to these items, please let them know that these are not open to the public.

We may be having special board meetings during the summer if needed as the board and committees are busy trying to finish up some long-standing projects. We would like to include all the snowbirds and now have the technology to do so via Zoom. This is an app that you would download, and we can send you a link to your email to join the meeting. Please make sure we have your email address, one per household, that you would like to use for this.

Projects that we are working on with committee's are:

- The back gate project – which includes a new barcode reader system, cameras at the back gate similar to the one at the front entrance and a cable installation to run a modem for the recordings from the cameras. Special waterproof boxes need to be installed and electric power supplied. We continue to work on bringing this to completion
- The identification of circuits and correction of the electrical issues in the kitchen that have been a long-standing problem.
- Irrigation and landscaping that need to be repaired. Irrigation lines that need to be redirected. Bushes that need to be trimmed back in an effort to allow new growth to occur.
- We have voted for the new cable contract with Comcast which provides more benefits than our current contract
- Numerous issues with the pool heaters, which have needed multiple repairs and we are still awaiting parts.

This month's rule reminder is that regarding the maintenance of your home site – rule 3.1, 3.2 and 3.7. Home site must be kept orderly, neat, and clean and free of litter. If you are going to be gone for an extended period of time, shareholder must make arrangements for their site to be maintained to the standards established by the Board. Members and Tenants are required to register a summer caretaker with the office. 3.12 any resident who will be away for 7 days or more during hurricane season, June 1 through November 30 must secure or stow away all outdoor objects. See your copy of rules and regulations for more details.

We want to thank all of you who have so kindly volunteered to serve the park in a variety of ways, including committees. Our committees are established, and we had more volunteers than needed. The list of the committees and each one's members are posted on the bulletin board outside the club house. If you have not been called to serve at present, we may need to call upon you in the future. Again, we thank you for your generosity of your time.

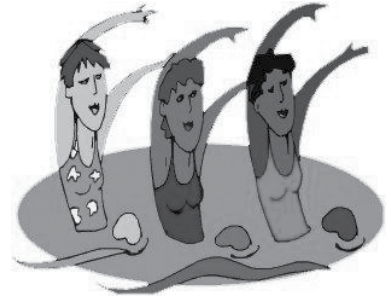
